

## **Oregon – Mobile Crisis Care Options**

When someone is experiencing a severe mental health crisis, they may need face-to-face response urgently. Mobile crisis providers will respond to wherever the crisis is occurring in the local community and will work to stabilize individuals in their home setting.

The providers listed below represent all available mobile crisis providers in the state – counties/cities they operate in and phone number. Counties without mobile crisis services are not listed.

Note: Each of these mobile crisis providers are available 24/7 and offer services to all ages.
