# **CLAIMS: Did You Know?**

- NPI number and complete diagnosis are required on all claims
- Filing deadlines are contract specific so please refer to your agreement
- Clean claims, including adjustments, are settled within 21 days of receipt
- Members cannot be balance billed for behavioral health services



# **Verify**

# Verify member eligibility before rendering services

To check member eligibility, providers can use the Indiana Health Coverage Program (IHCP) Program portal, the Optum Provider Express secure Provider Portal by <u>signing in</u> with a One Healthcare ID, or by calling the number on the back of the member's insurance card.



# Common claim mistakes

- Missing or invalid HCPCS/CPT code(s), diagnoses or data (# of units)
- Claim submissions with codes for services not contractually covered
- Billing provider is not enrolled with IHCP (steps to enroll)
- If a claim has been denied for coordination of benefits, resubmit a corrected claim for reconsideration

## **Avoid these form errors**

- Box 33 is for service location matching IHCP <u>not</u> billing location
- National Provider Identification (NPI) in box 24J does not match CMS 1500 (state filing)
- Box 33A: Group NPI must match the state record. This is <u>not</u> the space for individual provider NPI
- Taxonomy Code in Box 33B <u>must</u> match what the state has on file

# PRIOR AUTHORIZATION

To request a Behavioral Health Prior Authorization:

- <u>Log in</u> to the secure Provider Express Provider Portal and select "Auth Request" from the "Auths" dropdown ('Auth Inquiry' provides status updates)
- Call the number on the back of the member's ID card, or
- <u>Download</u> the form from the Prior Authorization and Appeals tab on the Provider Express IN page, complete and fax it to 1-844-897-6514
